Dear Mr. Dallaire,

Thank you for your comment letters for the above referenced project dated April 28, 2014. As you are aware Smith's Food and Drug Stores, Inc. is proposing to construct a fuel center within their parking lot at the existing Smith's #389 located at 1341 Highway 395 North in Gardnerville, Nevada. The existing Smith's has frontage along both Highway 395 and Waterloo Lane. As part of the initial Smith's development, two lots fronting Highway 395 were sold and developed (i.e. Taco Bell, and Jack In The Box). A freestanding "Center Sign" was constructed along Highway 395 including signage for Smith's, Taco Bell and Jack In The Box.

Smith's Food and Drug Stores, Inc. is requesting a Major Variance with Douglas County to increase the height of the existing freestanding "Center Sign" along Highway 395 from 20'-0" to 21'-10" (an increase of 1'-10") to incorporate signage for the proposed fuel center as shown in the attached drawing.

Smith's Food and Drug Stores, Inc. feels that increasing the height of the existing freestanding "Center Sign" by 1'-10" and adding signage for the fuel center is the least obtrusive option allowed for signage of the fuel center.

Smith's respectfully requests the ability to use the color scheme presented on the sign plan as it is Smith's Fuel Centers corporate colors and is critical to maintaining consistent identification throughout all of their locations.

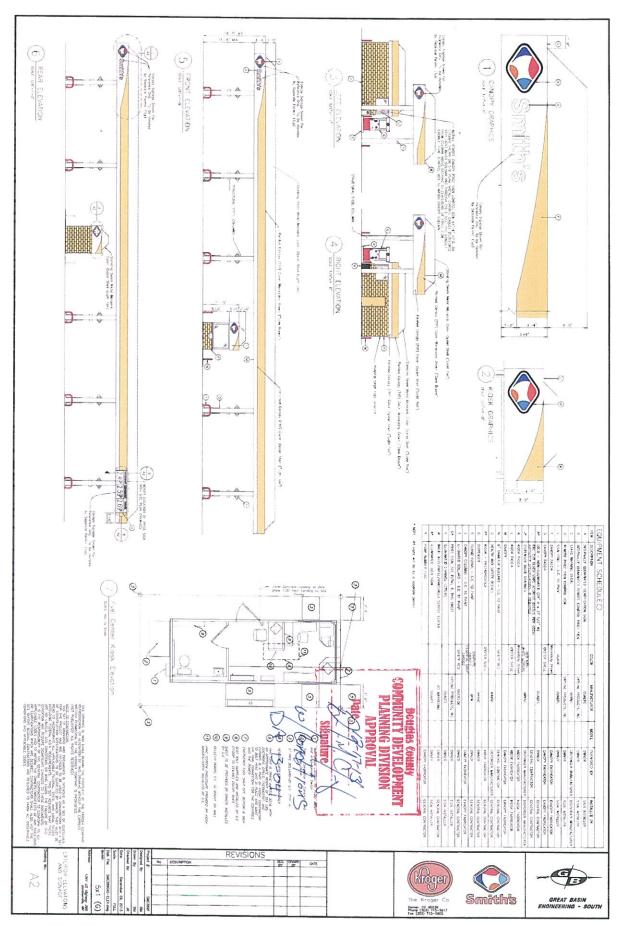

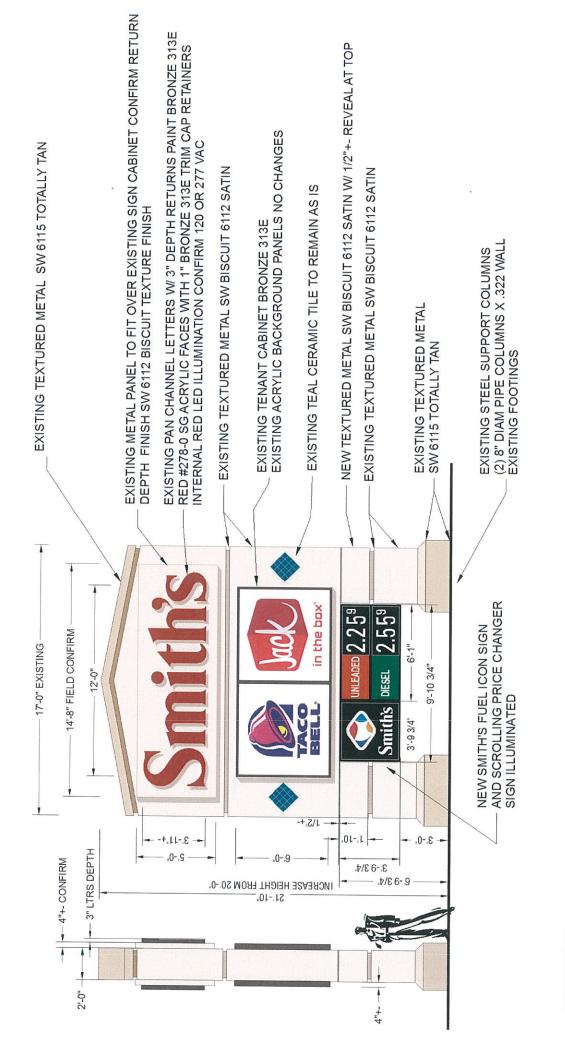

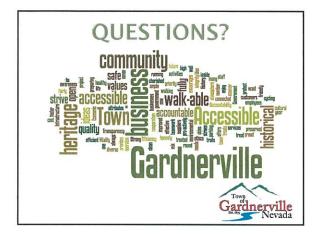
